

**CODE OF CONDUCT AND REQUIREMENTS**  
**FOR PLAYERS, COACHES, AND FAMILIES**  
**OF THE DAYTON AMATEUR HOCKEY ASSOCIATION**

In consideration of being a part of the Dayton Amateur Hockey Association (DAHA), I/We expressly agree to abide by any and all rules and regulations as established by USA Hockey, Mid-American Hockey Association, and DAHA. This includes all existing rules and regulations as well as any others which may be established at any point during the season by a DAHA coach, assistant coach, team representative, and/or the DAHA Executive Board.

A summary of some of these rules and regulations is listed below. You are encouraged to read and become familiar with the actual rules and regulations of USA Hockey, Mid-American Hockey Association, and the DAHA. A copy of the Bylaws of the Dayton Bluehawk Travel Hockey Club is attached.

1. All players, officials, coaches, operators, representatives, parents, and spectators will treat each other with mutual respect. No profanity, verbal abuse, or physical assault towards any player, coach, official, spectator, or representative will be condoned or tolerated.
2. Any disciplinary action taken by a coach toward a player must be done in the presence of at least one assistant coach, official, representative, team captain, or alternate captain.
3. Each player, or legal guardian is responsible for furnishing to his or her team representative at the time of registration a recent photograph, written waiver of liability, and a copy of that player's birth certificate. This is a prerequisite to be complied with before attending, traveling to, playing in any DAHA game, or participating in any DAHA activity.
4. Each player is required to attend all scheduled practices, meetings, and games of the DAHA team to which he or she is assigned unless prior permission to be absent is obtained from that team's coach, assistant coach, or team representative.
5. All coaches, assistant coaches, board members, parents, and players should be aware and conscious of gender and race equality and shall not knowingly discriminate on the basis thereof.
6. Any alcohol, smoking, and/or drug use by players is neither condoned nor tolerated and is subject to suspension, dismissal, or other disciplinary action by the respective team coach, assistant coach, and/or DAHA Executive Board.
7. Game misconduct penalties for any player, coach, assistant coach, or parent may result in an additional game suspension from the next DAHA game of his or her team. Additional penalties or disciplinary action may be rendered at the discretion of the respective team coach, assistant coach, and/or the DAHA Executive Board.

8. Any player who is suspended from playing in any DAHA game is still required to attend that game as a spectator unless prior permission to be absent is obtained from his or her coach, assistant coach, team representative, and/or the DAHA Executive Board.
9. All players must be at practice at least 30 minutes prior to the scheduled starting time or be subject to disciplinary action as determined by the coach or assistant coach of their team.
10. All players must be at games at least 45 minutes prior to the scheduled starting time or be subject to disciplinary action as determined by the coach or assistant coach of their team.
11. All players should be receiving passing grades at their respective schools as a condition of playing or practicing for any DAHA team. It is the responsibility of the parent or legal guardian to report any school suspension, whether academic or disciplinary, to that player's coach, assistant coach, or team representative. Any such school suspension may also be subject to a suspension from DAHA hockey or other disciplinary actions. DAHA supports good academics.
12. All players shall abide by any dress code established by their team coach, assistant coach, team representative, and/or the DAHA Executive Board.
13. All players shall pay any and all charges and fees by the fixed due dates established by their coach, assistant coach, team representative, and/or the DAHA Executive Board.
14. REMEMBER WHEREVER YOU ARE, YOU REPRESENT THE DAHA AND THE DAYTON BLUEHAWKS AND THE CITY OF DAYTON. YOU ARE EXPECTED TO CONDUCT YOURSELF ACCORDINGLY.
