**BY – LAWS of THE DAYTON SILVERSTICK REGIONAL
TOURNAMENT BRANCH OF THE DAYTON BLUEHAWKS
TRAVEL HOCKEY CLUB**

ARTICLE I - NAME

Section 1: The name of this Organization will henceforth be known as the Dayton Silverstick Regional Tournament Branch of the Dayton Bluehawks Travel Hockey Club and will be referred to herein as DSRTB.

ARTICLE II – PURPOSE

Section 2: The purpose of the DSRTB shall be to conduct and administer the Dayton Regional International Silverstick Hockey Tournament.

Section 3: Like the Dayton Bluehawks Travel Hockey Club, the DSRTB shall be operated on a non-profit basis.

ARTICLE III – OFFICERS

Section 4: All officers of the DSRTB shall be appointed by a majority vote of the Executive Board of the Dayton Bluehawks Travel Hockey Club.

Section 5: The term of each and every DSRTB officer shall not commence before June 1 of the year of appointment and conclude no later than February 1 of the immediately following year.

Section 6: The Officers of the DSRTB shall consist of the following:

- A. Tournament Director (or Co-Directors upon the discretion of the Executive Board of the Dayton Bluehawks Travel Hockey Club).
- B. Assistant Tournament Director(s), the exact number to be determined by the Tournament Director(s).
- C. Marshall(s), the exact number of which is to be determined by a majority vote of the Executive Board of the Dayton Bluehawks Travel Hockey Club.
- D. Treasurer
- E. Secretary
- F. Souvenir/Vendor Coordinator
- G. Lodging/Refreshment Coordinator
- H. Risk Manager
- I. Volunteer Worker Coordinator

Section 7: It shall be the duty of the Officers of the DSTRB to conduct all business of the Dayton Silverstick Regional Tournament in accordance with all pertinent rules and regulations of the International Silverstick Hockey Association, USA Hockey, and the Dayton Bluehawks Travel Hockey Club.

Section 8: An officer of the DSTRB shall not during the term of his/her office therein be also an officer or director of the International Silverstick Hockey Association.

- Section 9: Any DSTRB officer who fails to attend more than two consecutive DSTRB Officers Meetings may be removed and replaced by majority vote of the Dayton Bluehawks Travel Hockey Club Executive Board.
- Section 10: During the playing of the Dayton Regional International Silverstick Hockey Tournament, the Tournament Director(s) and Assistant Director(s) shall personally visit each rink where tournament games are being conducted at least once daily. The Director(s) must wear the official Silverstick coat or jacket identifying him/them as such
- Section 11: The duties of the officers of the DSTRB shall include but not be limited to:
- (1) Tournament Director(s) coordinate all operations of the tournament such as entries, deadlines, pairings, coaches, and referees, souvenirs vendors (including contracts for each specifying the share of gross profit revenue to be received by the Dayton Bluehawks Travel Hockey Club), payment of all pertinent fees and expenses as well as such other duties as may arise in the conduct or coordination thereof.
 - (2) Co-Director(s) or Assistant Director(s) assist the Tournament Director(s) with regard to the duties of the Tournament Director(s).
 - (3) Marshall(s) – are to serve as assigned and needed at any rink where tournament games are played and assist with all tournament operations as needed, subject to the authority of the Tournament Director(s) and/or Assistant Tournament Director(s).
 - (4) Treasurer is responsible for the collection, maintenance, refunds, and payment of any and all monies of the Dayton Silverstick Regional Tournament and shall provide a full and final accounting within 30 days after conclusion of each year's tournament to the Tournament Director(s) and the Executive Board of the Dayton Bluehawks Travel Club.
 - (5) Secretary is required to keep a true and accurate record of all proceedings and meetings of the DSTRB, be responsible for all correspondence, meeting notices, and acts as the custodian/depository for any and all team registrations and other documentation pertinent thereto.
 - (6) Souvenir/Vendor Coordinator shall secure any and all souvenir vendor and/or volunteers as requested by the Tournament Director(s), assist as needed with obtaining the signature(s) of any and all said vendors or contracts/agreements for revenue sharing between said vendors and the DSRTB, collecting such revenues due to the DSRTB, and perform such other functions as assigned by the Tournament Director(s).
 - (7) Lodging/Refreshment Coordinator – shall be responsible for negotiating and/or administering hotel/motel/housing accommodations as well as food and beverage service for tournament officials, referees, and spectators as needed.

- (8) Volunteer Coordinator -- shall be responsible for contacting each team manager within the Dayton Bluehawks Travel Hockey Club and assuring that each team thereof has the appropriate number of volunteers from among its parents, players, or others to staff check-in tables, score board operation, scorekeeper operation, penalty box operation, and/or other duties as may arise regarding the operation of the tournament.

Section 12: Upon the resignation, retirement, disability, or death of any DSTRB officer, his/her replacement shall be appointed by a majority vote of the Executive Board of the Dayton Bluehawks Travel Hockey Club.

Section 13: Any reimbursement for costs or expenses advanced on behalf of the DSRTB by any officer, agent, representative, contractor, or volunteer shall be solely limited to the amount of the specific actual amount of said expenses and then only for that portion thereof specifically related to the Dayton International Regional Silverstick Hockey Tournament as shown by receipt or other method of proof as determined by the Executive Board of the Dayton Bluehawks Travel Hockey Club and as subject to approval by a majority vote of said Board.
